### **General**

The protection and security of your personal data is very important to us. This website thus stores and processes data exclusively in accordance with the Austrian and European General Data Protection Regulation (GDPR). You as the user agree to data processing within the sense of this Statement. This Privacy Policy applies to this website only. If you are forwarded from our pages via links to other sites, you need to inform yourself directly on the website you are redirected to on how your data is handled. We process your personal data (for example, title, name, address, email address, telephone number, bank details, credit card number) only in accordance with the provisions of the Austrian data protection law. The following rules will clarify the nature, scope and purpose of the collection, processing and use of personal data.

You usually do not need to provide personal data to use this website. If we collect personal data on our pages (such as name, address or email address) this will always be on a voluntary basis as far as possible. We will not share such data with third parties without your express consent.

However, we would like to point out that data transmission over the Internet (for example, when communicating by email, or over unencrypted websites) may not always be secure. The end-to-end protection of data against access by third parties is thus not possible.

If commissioned through our website, we will manually or automatically check your submitted or entered data against the existing database on validity and timeliness and adjust data, if necessary to correct the data stored with us. It may become necessary that one of our employees needs to contact you. This will be either by email or by phone. The data you entered will be used exclusively to process your order or your subscription. We do not disclose your data to third parties.

### **Rights of the data subject**

You as the data subject enjoy substantial rights under the EU Data Protection Regulation. In particular, these rights are intended to ensure greater transparency in connection with your data. As the data subject you have the right to information about your personal data, rectification, erasure and to limit processing, object against



processing (direct marketing) as well as on data portability (only under a contract relationship or upon consent) and the right to revoke your consent at any time.

### **Data erasure**

Your data will be deleted as soon as our contract with you is fulfilled and the retention of data is not required by law. Basically, your data will be deleted after seven years; with a retention period pursuant to § 132 BAO (Austrian Fiscal Code).

Statutory/legal retention obligations or contractual obligations, for example vis-à-vis customers for the purpose of warranty or compensation or vis-à-vis contractors will define whether personal data must be kept longer. (Article 6 (1) (c) GDPR - Lawfulness of processing: legal obligation).

### **Customer account**

When you create a customer account with us, you will get password-protected access to our Shop. Please keep the password safe. Here you can view your open or completed orders and manage the data you have provided. We strictly adhere to guidelines and all the legal provisions of the European Data Protection Regulation with regard to storage and use of your personal data. We store your personal data only to be able to process your order, handle possible guarantee and warranty cases and to comply with legal requirements with respect to the retention of records. We do not save bank or credit card data transmitted during the transaction. Credit card details to the processing bank are transmitted in a secure SSL environment and cannot be viewed by third parties. For the purpose of processing your order, your data may be forwarded to the service providers we use (for example, post office or banks). These providers may only use the data to process your order properly. Use of the data for other purposes is excluded.

We check outbound links from our website very carefully. Nonetheless, we cannot and will not take responsibility for the content on the pages linked to from this website or any other Internet presence.



### **Job application form**

If you submit to us your job application via the application form, we will save this data, including the contact details you have entered there, in order to process your application. We will not share this data without your consent. 6 months at the latest after the post has been filled, we will delete your submitted and transmitted data.

### **Contact form**

If you use the contact form to send us inquiries, we will save the details contained in the inquiry form including the contact details you have provided in order to process your request and for possible follow-up questions. We will not share this data without your consent.

### **Raffle**

If you take part in our raffle advertised on the homepage, we will save the details you have provided in the form including your contact details in order to conduct the raffle. We will not share this data without your consent. Your data will be automatically deleted as soon as the raffle is over.

### **Data inventory**

We will not share your personal data with third parties that are not involved in fulfilling the contract without your explicit consent or without legal basis. After the contract is fulfilled, your data will be blocked from further use. After tax and commercial law requirements have been fulfilled, your data will be deleted, unless you have expressly consented to the further use of our data.

Where your personal data is required for reason of the contract, content design or changes to the contractual relationship (data inventory), your data will be used only for the purpose of contract processing. For example, in order to deliver the goods, we will share your name and address with the delivery service.

### **Credit review**

If we pay in advance, for example, in the case of payment on invoice, we may perform a credit check on you.

In such a case we will forward your personal data (such as name and address) to this company. By means of a mathematical-statistical method, the credit risk is assessed as to payment default. Whether we conclude the purchase contract will depend on the result of the credit review.

### **Information on cookies**

We deal with three different types cookies:



- # Strictly necessary cookies to ensure the website's basic functionality
- # Functionality cookies to ensure website performance
- # Targeting cookies to enhance user experience.

Some websites use so-called cookies. Cookies do not harm your computer and do not contain viruses. The use of cookies is meant to make our website more user-friendly, more effective and safer. Cookies are small text files stored on your computer and saved by your browser.

Most of the cookies we use are so-called "session cookies", which are automatically deleted when you close your browser. Other cookies remain on your device until you delete them. These cookies allow us to recognise your browser the next time you visit our website.

You can change your browser settings so that you are informed whenever cookies are saved. You can allow cookies only in individual cases, accept cookies in specific cases or block cookies in general and enable to automatically delete cookies when you quit your browser. ### **Google AdWords**

We also make use of the advertising tool "Google AdWords" to promote our website. As part of the service we use "Conversion Tracking" on our website provided by Google, Inc., 1600 Amphitheatre Parkway, Mountain View, CA 94043 USA. If you arrive to our website via an ad by Google, a cookie will be stored on your computer. Cookies are small text files that your Internet browser saves and stores on your computer. These so-called "conversion cookies" expire after 30 days and are not used to identify you. While the cookie is still active, we and Google will know when you visit our website that you are a user who was referred to our website by one of our Google ads.

Data obtained by means of "conversion cookies" is used by Google to create statistics for our website. These statistics show us the total number of users who clicked on our ad and also which other pages of our website those users visited afterwards. But we do not receive any data that could possibly identify users.

### **Facebook Pixel**

### **SSL encrypted connection**

This site uses an SSL-encrypted connection for security reasons and to protect the transmission of confidential content, such as requests you send to us as the site operator. The browser's address bar will tell you whether a connection is secure. The address bar will change from “http://” to “https://” and you will also see a lock icon in the address bar.

Data you send to us cannot be read by third parties, if an SSL-encrypted connection is active.
